You must confirm with your college what programs are TEACH Grant eligible. These normally include high-need fields like math, science, foreign language, special education (<i>these vary by state make sure to check yours</i>). After you complete your degree you are required to work in a school that serves low-income students and teach in a high-need field for four years, you have eight years to complete this. If you do not complete this your grant converts to a unsubsidized loan and you must repay it with interest. Read the requirements carefully before committing as they might change.
